JOB DESCRIPTION:

Utah Foundation is seeking a Research Analyst to perform public policy analysis and outreach. This is a full-time, salaried position. Candidates must have a strong desire to perform analysis of public-sector issues in a professional, nonpartisan setting and must demonstrate an understanding of public policy topics such as education, healthcare, economics, and/or tax policy. Although Utah Foundation is not an advocacy organization, this position offers an excellent opportunity to be involved in public policy making by attending hearings, testifying as a policy expert, participating in working groups and conferences, and interfacing with the news media, academia, and other interested parties.

JOB QUALIFICATIONS:

- Clear and articulate writing style
- Strong data analysis skills
- Experience working with financial and demographic data
- Strong people skills, with enthusiasm for public speaking, interviewing, and other outreach activities
- Strong proficiency in Microsoft Word and Excel required, with statistical analysis software proficiency a bonus
- Ability to analyze complicated subjects in an objective, even-handed manner
- Ability to direct one's own daily activities with a high degree of productivity toward meeting regular deadlines, working both as sole researcher and as part of a team
- A passion for improving public decision making through insightful analysis
- Master's degree in public policy, public administration, health policy, economics, or related subjects preferred
- At least two years of experience is preferred
